are not intentionally used and not known to be present in our raw materials substances listed by the European Chemical Agency (ECHA) in the “*Candidate List of Substances of Very High Concern*” (SVHC) for Authorisation”, **lastly updated on July 16, 2019** and in Annex XIV of Regulation (EC) 1907/2006 (List of substances subject to authorisation).

In the products in the following list a SVHC (Boric acid EC no.: 233-139-2 | CAS no.: 10043-35-3 ) is used in quantity higher than 0,1 %

- **MASTER PA 0005 C ARANCIONE**

About the inclusion in the SVHC list of bis(2-ethylhexyl)phthalate (DEHP), we communicate that this phthalate is a minor component of the catalytic system for polypropylene synthesis. This substance could be present in traces in polypropylene, however in a level much lower than the 0,1% for which the obligation of communication to the customer is required.

From the foregoing we can confirm that there is no reason that said SVHC substances may be found in the a.m. materials as supplied in original packaging.

Even for **traded materials** (such as natural PP, PE, PS, SAN, ABS, PMMA, PUR received in original bags) we were not informed by the producer about the presence of SVHC substances exceeding 0,1%.

We also confirm that our mentioned products comply with the restrictions set by the REACH Regulation 1907/2006/CE, annex XVII "Restrictions on the manufacture, placing on the market and use of certain dangerous substances, preparations and articles" and following amendments.

This declaration applies only to the composition of granules, and may not be extended to end products obtained by any modification of the composition, any processing conditions which could lead to deteriorated material or improper use of granules. Residual levels in final part could be affected by processing conditions; therefore, the exact content in the final part needs to be tested by the applicant.

The products listed above are not tested to check any possible presence of the substances mentioned above. Please note that this testing process is not a standard procedure within Sirmax SpA.
